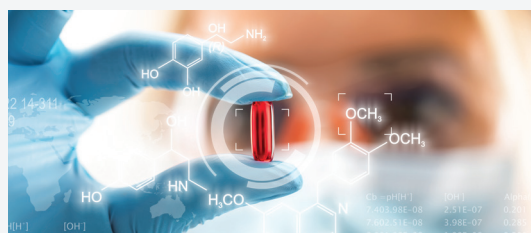
Unit Packs & Packaging:
